

## **CONFLICT OF INTEREST POLICY**

It is important that you return this form as early as possible in the publication process. We will not publish your article without completion and return of the form.

The International Journal of South American Archaeology – IJSA (eISSN 2011-0626) requires that all authors sing a declaration of conflicting interest. A conflicting interest exists when professional judgment concerning a primary interest may be influenced by a secondary interest (such as financial gain or personal rivalry). It may arise for the authors of an IJSA paper when they have a financial interest that may influence their interpretation of their results or those of others.

We believe that to make the best decision on how to deal with a paper we should know about any such conflicting interests that authors may have. We do not aim to eradicate conflicting interests – they are almost inevitable. We will not reject papers simply because you have a conflicting interest but we will make a declaration on whether or not you have conflicting interests.

We do not have an absolute definition of what constitutes a conflicting interest. However, the following are examples of facts that we believe readers should be aware of when reading your article.

## **FINANCIAL INTERESTS**

- 1. Have you in the past two years accepted any of the following from an organization that may in any way gain or lose financially from the results of your study or the conclusions of your paper?
  - A fee for speaking
  - A fee for organizing education
  - Reimbursement for attending a symposium
  - Funds for research
  - Funds for a member of staff
  - Fees for consulting and/or serving on an Advisory Board
  - Patent rovalties
- 2. Have you in the past five years been employed by an organization that may in any way gain or lose financially from the results of your study or the conclusions of your paper?
- 3. Do you hold any stocks or shares in an organization that may in any way gain or lose financially from the results of your study or the conclusions of your paper?
- 4. Have you acted as an expert witness on the subject of your study or paper?
- 5. Do you have any others competing financial interests? If so, please specify.

If you feel that any of these will apply to your paper we consider that you may have a competing interest, which, in the spirit of openness, should be declared. Please use the accompanying from to draft a statement to publish with the article.

## **RESEARCH SPONSORSHIP**

Please remember that we require you to disclose any sponsorship that you received to help conduct the study. This might take the form of, for example, that "This study was carried out with support of an unrestricted educational grant from X" or "This study was funded in whole/in part a grant from Y". This information will be published together with the author affiliation information.
